Id-uz-Zuha, Muharram, Milad-un-Nabi and Id-ul-Fitr which fall on 23rd February, 25th March, 25th May and 6th December, respectively are subject to change depending upon the visibility of the moon. If the Government of India declare any change in these dates through TV/AIR/Newspaper, the same will be followed. 5.
